## 2020 Was Devastating To The Already Downtrodden

COVID-19 and racial unrest have made 2020 a year like no other. Most of us were privileged to go through the pandemic relatively unscathed. But our neighbors in need were not so fortunate. As low-income jobs in restaurants, hotels, bars, factories, home services and other industries dried up, so did income and access to justice. But the oppressive forces did not relent. Evictions still took place, financial scams still occurred, youth still got targeted for sex trafficking, and single moms felt the additional burden of unmet support. 2020 was not a good year for someone already behind the proverbial 8-ball.

## As Needs Increase, Resources Have Decreased

Administer Justice is in this storm with what the Bible refers to as “the least of these”. Clients needing help are up 30%, yet traditional giving via donations is down 20%. ## Business Leaders Are Called To Plant & Multiply

The parable Jesus told of the talents in Matthew 25 was a business story. It spoke of a businessman and his employees as they went about their roles. Some understood their calling to invest resources to multiply them. One, unfortunately, misunderstood his purpose completely. Regardless of the type of year you had in 2020, perhaps God is providing an opportunity to recognize how blessed you are - and what resources He is looking to you to invest in fruitful multiplication.

## An Opportunity To Invest In Self-Sustaining Multiplication

It is hard to find ministries that understand the concept of self-sustaining. Administer Justice is different. Each gospel justice center we launch with your investment of \$5,000 becomes self-sustaining within 12-18 months. That is because every client pays a small dignity fee of \$30 to access the help of a lawyer. Clients understand that this is not a free handout. That small fee multiplies over 100 clients a year to fund the center’s operating costs. **Your one-time investment, launches a gospel justice center that does not need your funding thereafter.** That center will operate with 10 volunteers and serve 100 clients a year, year-after-year. This is true ministry impact through multiplication. Each year, you can help launch new centers as the Lord calls.
