2024: A YEAR OF CONNECTIONS

2024 was marked by deep divisions intensified by a contentious election. That's why Administer Justice is committed to fostering connection – uniting churches, attorneys, volunteers, donors, and clients around a shared mission: to "Administer true justice; show mercy and compassion to one another." (Zechariah 7:9)

Administer Justice connects the local church to its community by establishing Gospel Justice Centers. We connect people in need to the church by addressing urgent legal issues. We connect volunteers with opportunities to use their gifts in service. And we connect donors with the chance to make a lasting impact in the lives of those who cannot afford legal representation.

2024 was a year of incredible growth. We doubled the number of Gospel Justice Center

grand openings – from 15 to 30. We engaged 31% more attorneys, 22% more volunteers, and expanded our centers by 23%, existing in four more states than last year. We also saw a 32% increase in total giving through donated services and financial contributions.

But the most important connection happens between a client and a Gospel Justice Center team.

That's how I met May–a neighbor seeking protection from abuse and facing other legal challenges. A caring team not only provided legal help but also built a relationship. Today, I worship alongside May every Sunday as she thrives as part of our church family.

We are grateful for every connection made in 2024 and look forward to even more as we celebrate 25 years of service in 2025!

GOSPEL JUSTICE THROUGH THE HOME OF A CHURCH.



Suddenly, they are not just clients, but individuals woven into the beautiful tapestry of God's Church.

Our partner churches witness the transformation firsthand. By offering practical legal help to neighbors in need they strengthen both their communities and congregations and live out the call to seek justice, love mercy, and walk humbly with God. Administer Justice centers are advancing Gospel justice – one church, one client, one life at a time.


EMPOWERED BY HELP, HOPE, AND NEXT STEPS

The legal system is complex, overwhelming, and often impossible to navigate alone. The high cost of representation continues to put justice out of reach for millions. In 2024, the U.S. ranked 107th out of 142 countries, the lowest among high-income nations, for accessible

civil justice. It's no surprise that over 90% of legal issues faced by low-income Americans go unaddressed.

Beyond legal barriers, economic instability and job insecurity deepen despair. Gospel Justice Centers stand in the gap by offering help, restoring hope, and pointing the way forward. Even in challenging times, we are witnessing a movement of God's love through legal ministry.

At the heart of this work are the clients we serve. Throughout 2024 one measure remains steady: clients consistently report experiencing love and renewed hope during their appointment. Many arrive overwhelmed and trapped, but as they meet a team that listens, guides, and cares deeply, transformation begins. Legal battles can last months or years, but no client walks alone. Through ongoing support, practical resources, and the unwavering presence of a church community, they are empowered to overcome obstacles and move forward with confidence.



Each week, individuals arrive at Gospel Justice Centers carrying legal burdens. Some find clear solutions, while others face challenges with no easy remedy. Outcomes may not always be what they hoped for, yet one thing remains constant: the power of compassionate care.

These stories offer a glimpse into the ongoing impact as lives are touched and hope is restored.





Abigail

Abigail was facing a lawsuit from her ex, an eviction notice, and the challenge of clearing out her storage unit, all while living in a shortterm rental.

With nowhere to turn, she came to a Gospel Justice Center. There, volunteers connected her to stable housing, a new job, and legal support, helping her regain stability and find hope.



Fredrick

Struggling with debilitating pain and a cancer diagnosis, Fredrick could no longer work and needed help applying for Social Security disability.

At a Gospel Justice Center, an attorney provided clear guidance on requirements and next steps. With this support, Fredrick is now navigating the process to secure the financial assistance he needs.

Carly

After discovering her car insurance was set up incorrectly after an accident, Carly found hope through a Gospel Justice Center.

A volunteer attorney guided her to proper coverage and reimbursement and offered prayer at every step. Her crisis was turned into a testimony of God's provision through the center's faithful servants.

THE HANDS AND FEET OF GOSPEL JUSTICE

The church has always struggled and fallen short of embodying God's justice for all. Even a brief study of the prophets shows that this challenge is not unique to our present context.

We exist in a culture faced with tensions. Yet the calling to love our neighbors in this difficult time includes doing justice. As the prophet declared centuries ago, "Do justice and righteousness, and deliver from the hand of the oppressor him who has been robbed. And do no wrong or violence to the resident alien, the fatherless, and the widow, nor shed innocent blood in this place." (Jeremiah 22:3b)

The church should be engaging in discussion and wrestling with what "doing justice" in our communities looks like today. Yet one truth remains clear: we have a definite calling to pursue justice for those in need, and Scripture offers serious warnings when this calling is ignored.

Administer Justice is blessed with a multitude of Christ-followers who feel this calling in a deep and personal way. The urgent need for justice in our society outweighs any conflicts about who should provide it or how. In 2024, we continued to see more volunteers step forward, giving their time generously and caring deeply. We now have volunteers across 19 states who are motivated to provide justice to the overlooked and outcast.

Seven years ago, a friend invited Janet to an Administer Justice fundraiser. At the event she felt moved and knew she wanted to be part of this work. When her pastor later mentioned starting a legal clinic at their church, she felt the Holy Spirit move and she raised her hand immediately.

Then, she encountered set-backs. Everyone she asked to join the team said no. But God worked in incredible ways to bring a team together from unexpected places. Today, Doorway to Hope is a thriving center, helping many in the greater Elgin area. Janet has seen lives change. Clients walk in anxious, shoulders hunched, eyes downcastbut they leave with hope, standing tall. One refugee family received a truck full of furniture through a connection made in the waiting room. A Judson University student found a mentor. Time and again, God reveals himself in unexpected ways.

Administer Justice has meant so much to her, but especially since losing her husband, John. This work has given her purpose, drawing her closer to God and reminding her why she's here. The clinic, Doorway to Hope, has helped hundreds of clients-and it has helped her, too.

BRIDGING THE JUSTICE GAP

"Shouldn't I help those in need? How hard could that be? Am I too important? Can I not spare a couple hours a month?"

These heart-searching questions come from a volunteer attorney whose day job involves "helping big businesses fight over small problems...and spend a lot of money doing so."

Through the transformative power of compassionate legal ministry, clients journey from places of fear, uncertainty, and confusion into spaces of confidence and renewed hope. Attorneys like the one quoted above witness firsthand how their God-given talents become instruments of restoration in these sacred encounters

While attorneys possess specialized skills and focused legal expertise, even they experience

moments of uncertainty when stepping outside their familiar practice areas. Yet time and again, they set aside these concerns, offering their authentic presence and caring hearts.

94% of clients report that they were helped with their legal needs. Beyond practical advice, these appointments become spaces where clients experience being truly heard and valued. The attorney provides advice, and the rest of the volunteer team comes alongside to provide prayer and holistic care.

Our system and society often overlooks the type of client our centers serve, but we remain steadfast in our calling to see each person as God sees them, with inherent dignity and infinite worth. In this way we participate in God's redemptive work in our communities.

HOW HAS SERVING AT A GOSPEL JUSTICE CENTER IMPACTED YOU?

"First, it has been another example of how God's timing and his providence give us what we need to serve others beyond our own capacity at just the right moment. Second, it has been a regular reminder of the "barriers to entry" imposed by our legal system. Third, it has revealed to me some of the deepest pain and the worst wounds — client situations I would never see in my own practice — where people need a lifeline of love and support." "I have felt God's presence in the client meetings and have seen Him working through me and in the lives of others."

"It has made me more knowledgeable and attuned to the plight of some people in the legal system, particularly with respect to immigration."
